I. Call to Order

II. Approval of Meeting Minutes from May 6th, 2020

Lois moved to approve the minutes. Robb Seconded the motion. All committee members present voted in favor.

III. Proposed Bike Park – Matt McIsaac, Trisha Oakland

Chase gave the committee a quick summary of his previous discussion with Matt McIsaac about the possibility of a bike park on the southern end of the Athletic Park. This included; location, plans for baseball expansion, the need to raise/provide funds, need to show community interest and how the existing track is not used or maintained.

Matt went on to describe his coaching and experience in the biking community. He described potential community and economic benefits, using a successful park in Grand Junction as an example. The pump track would be paved so would have little maintenance and help to spread out the skatepark users. Matt and Trisha Oakland have been working with the American Ramp Company for conceptual designs and can show community support in the next Parks Committee meeting. As this time, they are not asking for financial contributions, only for the land and a water tap/spigot if possible.

Trisha Oakland said there is a possibility to partner with Voyager or another 501(C)3 organization like Colorado Plateau Mountain Bike Trail Association (COPMOBA) for fundraising and tax-exempt donations. This project is not looking to partner with Ridgway Area Trails (RAT). Trisha described that a bike park would fill a gap for youth programs and skill range to help keep kids on bikes.

The Committee Members expressed support but requested the following from Matt and Trisha:

- Make sure the land isn't restricted and can be utilized for a bike park
- Show that there is community support
- Talk with the other established Athletic Park user groups
- Develop a maintenance and operations plan

#### IV. Hartwell Planters

The Hartwell planter boxes have been upkept by Vicki and Charlie Spencer for years and they are moving away. As a small thank you, Sue Husch and Town Staff will work to submit a letter to the editor showing appreciation for their volunteer service.

V. Baseball Update

The Town has received quotes on infield mix and will have it delivered shortly. There was a request to put up a sign for the Montrose Community Foundation Grant. Staff to explore possibilities with signage restrictions and keep it small and simple.

VI. Athletic Park Pavilion Update

The Pavilion had to be raised to avoid groundwater and the contractor is pouring concrete now.

VII. Heritage Park Improvements

A gravel area with picnic tables was installed and the Visitors Center got a new flier distribution box.

VIII. Town Trees – Cottonwood Creek, Plantings, Removals and Survey

There has been an unexpected dieback in Town trees and a number have had to be removed. Hoping to replant many this fall. The Forest Service survey update is nearing completion. The property owners who have pipe running along their bank no longer want it there so a new solution must be found.

## IX. New Business

The committee expressed concern over water usage and the drought. They inquired about enacting voluntary or mandatory restrictions and changing the Town landscaping codes. Erin brought up irrigation incentives and a successful program enacted in Mountain Village to provide irrigation systems with "smart" controllers. Chase to look into the program and possibility of having the similar in Ridgway.

## SUMMARY:

Mayor Clark has suggested that the Town place a memorial plaque on the north pavilion in Hartwell Park, recognizing Richard (Dick) Louis Spirek, Jr and Mary Ellen (M-E) Spirek, two longtime Ridgway residents who recently passed away. They were both very active in the community and had a passion for volunteering in a number of ways.

The Town has a *Memorial Donation and Gift Policy* in place, included as Exhibit 1, and while this request does not exactly fit within the parameters of the policy, staff feels that since the request revolves around a memorial on a Town-owned facility, the request should follow the formal procedures outlined in the Policy. According to the Policy, a completed *Memorial Donation and Gift Agreement Form* must be submitted to the Parks, Trails and Open Space Committee. The Committee must review and determine the appropriateness of the proposal as measured by the stated approval criteria. Approval from the Committee must be received before installation of the memorial may proceed.

Attached as Exhibit 2 is a completed *Memorial Donation and Gift Agreement Form*. To supplement the Form, below is the proposed inscription for the plaque that would be installed on the facility:

### Memorial Donation and Gift Policy February 5, 2016

#### Purpose:

To establish guidelines for the consistent decision-making process related to the acceptance, placement and long-term maintenance of public requests for memorial donations and gifts in Town-owned facilities, parks, rights-of-way, natural areas and trails.

#### Background:

Memorials and gifts have augmented Ridgway's properties and facilities. Historically, the Town has accepted these donations without a formal written policy. Guidelines are also needed for sustainable management of site-appropriate amenities, so as to maximize the Donor's intent, to not detract from the visual aesthetics of the surrounding natural environment, and to not place an undue burden on the Town.

#### Management Philosophy:

The protection of the natural environment is a high priority. To this end, the Town of Ridgway may manage and limit memorials in order to promote resource management and sustainability of natural landscapes. The integrity, natural and architectural features of parks, natural areas and facilities will be preserved and not detract from a user's experience. Final decision on the acceptance and placement of memorials may be made by the Ridgway Parks, Trails and Open Space Committee.

#### Procedures:

- The Donor submits a completed Memorial Donation & Gift Agreement Form to the Parks, Trails and Open Space Committee;
- The Committee reviews and determines the appropriateness of the proposal as measured by approval criteria and will notify the Donor as soon as possible, identifying any final conditions of approval;
- The Town does not guarantee permanency of the memorial or gift. If a memorial or gift must be relocated, the Committee will attempt to notify the donor, in writing, at the address shown on the completed Memorial Donation and Gift Agreement Form;
- The Town takes no responsibility to replace stolen, vandalized donations or for the maintenance or replacement of trees that are not watered by an automated irrigation system, and/or where a Donor has agreed to a accept responsibility for watering the tree;
- The Parks, Trails and Open Space Committee's approval must be received before installation of the memorial or gift may proceed;

• The Town may agree to be responsible for the installation, maintenance and protection of the work, within reason. Once installed, the memorial or gift becomes Town property.

#### Guidelines:

All proposals will be evaluated by the Parks & Trails Committee according to the following:

- Memorials and gifts cannot have a commercial appearance or corporate label;
- Design specifications and placement of enhancements on Town-owned properties must be compatible with the existing Ridgway Parks & Trails Master Plan and the Town of Ridgway Master Plan;
- Preliminary decision as to location will be approved by the Ridgway Parks & Trails Committee;
- Memorials and gifts shall not detract from or overpower the scenic or architectural values of the existing environment;
- Memorials and gifts will be constructed of materials that meet the design and maintenance considerations of the Town of Ridgway;
- Donations of any living items (eg: trees) will be considered on an annual basis in conjunction with the Town's planning and budgeting initiatives, and must be part of a comprehensive plan including ease of access to an automated watering system, water conservation and limited maintenance obligations;
- Memorials and gifts which are large in scale will be considered on a case-by-case basis, as they relate to park planning processes and the Town's Master Plans;
- Non-designated monetary memorial donations or gifts will be used to meet the needs of the Town of Ridgway as recommended by Town Staff;
- Donations that incorporate: natural and /or recycled materials (eg: boulders), low-maintenance, durable materials, and creative elements are desired;
- The following donations are not desired: public art (*please work through a public art agency*); stand-alone plaques; live vegetation without access to water and not as part of a larger vegetation or master plan.

#### **Targeted Locations:**

#### Hartwell Park

Sited around the playground area and the perimeter of the park (*not in central open spaces*); In the amphitheater area around the stage are not desired, although higher up the hillside near the post office might be appropriate;

Benches near the BMX track are appropriate.

### Cottonwood Park

Parallel to Cottonwood Creek maximizing the San Juan views and Cimarron views; At trail access areas into the neighborhood (in the areas of extensions of Mary and Cora Streets).

### Heritage Park

In the park area, which is not subject to a lease; Not interfering with the Ridgway sign; This is not an ideal location for benches but they could be sited here.

### Green Street Park

Appropriate along trails and sidewalks maximizing view corridors and on the park perimeter (*not in wide open spaces*).

### Regional Athletic Park

2 or 3 practically sized picnic tables at the gazebo;

If benches, durable in design near the skate park;

Along the north side of the drainage between the basketball court and the drainage, if benches, maximizing views of the San Juan and Cimarron Mountains;

#### Uncompahgre RiverWay Trail

Strategically placed benches along the trail are appropriate as town property and easements allow.

#### Dennis Weaver Memorial Park

On the trails north of RiverSage Drive (similar to the Axel Memorial Bench);

The Eagle Memorial area, including the area down by the river, is to remain open and not incorporate memorials in this general location.

### <u>Rollans Park</u>

Near the trails and water access areas, if benches, preferably facing east/south for mountain views.

#### **Review and Update:**

This policy may be reviewed from time-to-time by the Ridgway Parks & Trails Committee and updated as needed with a recommendation to the Town Council.
