# Sustainability Advisory Board Meeting Minutes

## Wednesday, February 1, 2023

### 1. Call to Order and Roll Call

### 2. Discussion with Kim Wheels re: Differences between the 2018 IECC and the 2021 IECC.

### 3. Discussion re: Enhancing education on regional sustainability/climate action efforts

There was discussion regarding the importance of getting information out to the public on upcoming changes to the building code, and what energy rebate incentives will be available.
