Parks, Trails and Open Space Committee Meeting Minutes

Tuesday, September 6, 2022



1. Call to Order and Roll Call

The meeting was called to order at 5:31 p.m. and Parks, Trails and Open Space (PTOS) Committee members present were Sue Husch, Jared Coburn, Lois Ziemann, Erin Smith and Polly Enochs. Town Manager Preston Neill was also present. Dave Jones, Judi Chamberlain and Nick Williams were absent.

2. Approval of Minutes from July 5, 2022 Meeting

Sue made a motion to approve the minutes from the July 5, 2022 PTOS Committee meeting. Jared seconded the motion and the motion passed unanimously by members present.

3. Request for dedicated pickleball courts in Ridgway

Members of the Ridgway Pickleball Club presented a proposal for the construction of an eight-court pickleball complex on Town property at the Ridgway Athletic Park. The presentation covered the need, a cost estimate, and potential sources of funding. The presentation also described how the proposal is consistent with the Town's core values identified in the Master Plan. PTOS Committee members provided feedback on the proposal and suggestions were made for next steps. It was identified that the Ridgway Pickleball Club would make a similar presentation to the Ridgway Town Council at their regular meeting on October 12, 2022.

Jared made a motion to refer the proposal to the Town Council with support expressed from the PTOS Committee. Sue seconded the motion and the motion carried unanimously by members present.
