# Parks, Trails and Open Space Committee Meeting Minutes

### 1. Call to Order and Roll Call

The meeting was called to order at 5:35 p.m. and Parks, Trails and Open Space (PTOS) Committee members present were Sue Husch, Jared Cohburn, Judi Chamberlain, Dave Jones and Polly Kroger. Town staff representative Debra Overton was also present. Nick Williams, Erin Smith and Lois Ziemann were absent.

### 2. Approval of Minutes from May 2, 2023 Meeting

Polly Kroger made a motion to approve the minutes from the May 2, 2023 PTOS Committee meeting. Dave Jones seconded the motion and the motion passed unanimously by members present.

### 3. Ridgway Bike Park Presentation by Matt McIsaac

Matt provided a slide show with examples of bike park designs and concepts. He answered questions and informed the Committee that once the Master Planning process for the Athletic Park begins other designs will be considered.

### 4. Athletic Park Master Plan Update

The Town awarded DHM Designs to do the Ridgway Athletic Park Master Plan. A kickoff meeting with DHM and Town staff will take place followed by DHM meeting with stakeholders. A public meeting is scheduled for July 19<sup>th</sup>. The Master Plan is expected to be completed by the end of 2023.
