



C.2. THE CONTRACTOR IS RESPONSIBLE FOR REVIEWING AND UNDERSTANDING THE PLANS, SPECIFICATIONS, AND STANDARDS. CONTRACTOR SHALL EXECUTE HIS WORK IN ACCORDANCE WITH THE CONTRACT DOCUMENTS. ADDITIONAL WORK OR MATERIALS REQ'D TO BRING THE WORK IN CONFORMANCE WITH THESE REQUIREMENTS SHALL BE PROVIDED AT NO ADD'L COST TO OWNER

C.3. A QUALIFIED SUPERINTENDENT WHO IS ACCEPTABLE TO THE OWNER SHALL BE MAINTAINED AT THE WORK SITE AND GIVE EFFICIENT SUPERVISION TO THE WORK UNTIL IT IS COMPLETED. THE SUPERINTENDENT SHALL HAVE FULL AUTHORITY TO ACT ON BEHALF OF THE CONTRACTOR. AND ALL DIRECTIONS GIVEN TO THE SUPERINTENDENT SHALL BE CONSIDERED GIVEN TO THE THE CONTRACTOR. AT MOST TIMES, THE SUPERINTENDENT SHALL NOT BE ENGAGED IN DIRECT CONSTRUCTION OPERATIONS.

C.4. STATIONING AND ALIGNMENT FOR METERS, VALVE CLUSTERS, SERVICES AND HYDRANTS ARE APPROXIMATE AND MAYBE ADJUSTED BY ENGINEER IN THE FIELD. FOR VALVE CLUSTERS SHALL BE STAKED BY THE CONTRACTOR & APPROVED BY THE OWNER'S REPRESENTATIVE PRIOR TO INSTALLATION.

C.5. CONTRACTOR SHALL RECONNECT SERVICES. HYDRANTS & CROSS MAINS AS CLOSE TO PERPENDICULAR AS PRACTICAL.

C.6 CONTRACTOR SHALL PROTECT ALL WORK AREAS AND FACILITIES FROM FLOODING OR WATER DAMAGE REGARDLESS OF WATER SOURCE. ANY REQUIRED DEWATERING AND/OR RESTORATION REQUIRED SHALL BE PROVIDED BY THE CONTRACTOR AT NO COST TO THE OWNER.

C.7. CONTRACTOR SHALL PROTECT ALL EXISTING IMPROVEMENTS INCLUDING OTHER UTILITIES, LANDSCAPE, IRRIGATION, ETC. ALL COSTS ASSOCIATED WITH REPAIR OF IMPROVEMENTS SHALL BE BORN BY THE CONTRACT AT NO COST TO THE OWNER.

C.8. CLEAR & GRUB (C&G) INCLUDES REMOVAL OF ALL ROCKS, BRUSH, TREES, VEGETATION, TRASH, ETC. FROM WORK AREA. REMOVE & STOCKPILE ANY TOPSOIL. ALL C&G MATERIALS REMOVED BECOME THE PROPERTY OF THE CONTRACTOR AND SHALL BE REMOVED FROM PROJECT SITE & DISPOSED OF PROPERLY. CONTRACTOR SHALL CLEAR AND GRUB ONLY THE AREA TO RECEIVE WORK, C&G SHALL BE INCLUDED IN THE COST OF THE WORK THAT REQUIRES C&G.

C.9. WORK HOURS SHALL BE BETWEEN 7:30 AM AND 6:00 PM ON NON-CDOT HOLIDAY MONDAY-FRIDAYS EXCEPT AS NOTED IN SPECIFICATIONS.

## GENERAL NOTES

CONSTRUCTION (CONT'D)

C.10. CONTROL ALL DUST ON & OFFSITE WITH A DUST PALLATIVE APPROVED BY O.R. INCLUDE COST OF SAME IN THE COST OF THE ASSOCIATE WORK.

C.11. COST FOR TRIMMING VEGETATION THAT MAY INTERFERE WITH THE WORK SHALL BE INCLUDED IN THE COST OF THE WORK THAT REQUIRES THE TRIMMING. BEFORE TRIMMING SECURE APPROVAL OF PROPOSED WORK WITH THE PROPERTY OWNER AND THE TOWN.

CONTRACTOR SHALL COORDINATE WITH ADJOINING PROPERTY OWNERS WHEN WORKING ADJACENT TO THEIR PROPERTY. CONTRACTOR SHALL MAINTAIN ACCESS TO ALL PROPERTIES AT ALL TIMES.

C.13. CONTRACTOR SHALL TAKE MEASURES TO ENSURE THAT WATER CUSTOMERS SERVICES ARE NOT DISRUPTED FOR LONGER THAN THE TIMES ALLOWED IN THE SPECIFICATIONS.

C.14. CONTRACTOR SHALL RECONNECT ALL SERVICES WHETHER SHOWN ON THE PLANS OR NOT AND BE RESPONSIBLE TO ENSURE THAT ALL CUSTOMERS & BLDGS HAVE GOOD SERVICE AFTER BEING TRANSFERRED TO THE NEW MAINS OR BEING REPAIRED. SUCH CHECKS SHALL BE COMPLETED AS SOON AS THE SECTION OF NEW MAINS PUT INTO SERVICE

C.15. OWNER'S REPRESENTATIVE (O.R.) WILL DETERMINE WHETHER SERVICES SHOULD BE RECONNECTED TO EXISTING SERVICE LINE BY THE MAIN OR IF THE SERVICE LINE SHOULD BE EXTENDED TO THE METER & RECONNECTED AT THE METER. WHERE PRACTICAL THE INTENT IS TO RECONNECT SERVICE LINES CLOSE TO THE MAIN.

C.16. CONTRACTOR SHALL RECONNECT ALL IMPACTED SERVICES ON BOTH SIDES OF THE STREET TO NEW MAINS AND SHALL TEST THAT EACH CUSTOMER HAS BEEN RECONNECTED.

C17. SANITARY PROTECTION SHALL BE PLACED ON ALL WATER MAINS & SERVICE LINES WHEN THERE IS LESS THAN 18" SEPARATION BETWEEN THE OUTSIDES OF THE POTABLE AND NON POTABLE LINES AND WHEN THE WATER MAIN IS BELOW THE SEWER. ADDITIONAL REQUIREMENTS FOR SANITARY PROTECTION IN THE SPECIFICATIONS. WHERE THERE IS INSUFFICIENT SPACE FOR THE FULL ENCASEMENT SPECIFIED. CONTRACTOR SHALL NOTIFY ENGR WHO WILL DIRECT ADJUSTMENTS.

## CONSTRUCTION (CONT'D)

C.18. LOCATIONS OF SEWER SERVICES LINES ARE NOT KNOWN. IF THE WATER MAIN CROSSES A SEWER SERVICE WITH LESS THAN 18" OF SEPARATION, ENCASEMENT OF THE WATER LINE WILL BE REQUIRED.

C.19. PLANS SHOW SANITARY PROTECTION ON MOST SERVICE LINES. IF THE THE CONTRACTOR RECONNECTS THE WATER SERVICE LINE WITHOUT REACHING THE SEWER CROSSING, IT IS NOT NECESSARY TO INSTALL AN ENCASEMENT ON THE SERVICE LINE.

C.20. CONTRACTOR SHALL BE RESPONSIBLE FOR STAGING & ACCESS POINTS.

C. 21. ALL WORK SHALL BE COMPLETED FROM WITHIN EXECUTED EASEMENTS OR RIGHTS OF WAY. NOTIFY ENGINEER SHOULD CONFLICT ARISE, USE OF ADJOINING PROPERTY IS PROHIBITED UNLESS CONTRACTOR MAKES ARRANGEMENTS WITH ADJOINING LAND OWNER AND PROVIDES EXECUTED DOCUMENTATION OF THOSE ARRANGEMENT TO ENGINEER & ENGINEER DETERMINES THAT THE DOCUMENTATION IS ADEQUATE. USE OF HAND TOOLS IS REQUIRED IN CLOSE PROXIMITY TO ROW LINE.

## **UTILITIES**

U.1 THERE ARE WATER, SEWER, IRRIGATION, POWER, PHONE, & FIBER LINES PRESENT IN THE STREETS, & EASEMENTS IN THE WORK AREA. CONTRACTOR SHALL POTHOLE CROSSING UTILITIES IN ADVANCE OF WATER LINE EXCAVATION AND DETERMINE WHETHER THERE WILL BE CONFLICTS. IF CONFLICTS ARE ANTICIPATED, NOTIFY ENGINEER FOR RESOLUTION. INCLUDE COSTS OF POTHOLING, OTHER LOCATION EFFORTS. & COST OF ADJUSTMENTS SHALL BE IN THE COST OF THE BID ITEM FOR WHICH THE WORK IS NEEDED.

U.2. CONTRACTOR SHALL EXPECT TO ADJUST WATER LINE ELEVATION DOWN UP TO 12" FROM THE 5' OF COVER FOR SHORT DISTANCES TO GRADUALLY CROSS UNDER CONFLICTING OBSTACLES AT NO ADDITIONAL COST TO THE OWNER.

U.3. NOT ALL UTILITY LINES AND BURIED INFRASTRUCTURE ARE SHOWN ON THE PLANS AND LOCATION OF THOSE SHOWN ARE ONLY APPROXIMATE.

U.4. THE CONTRACTOR SHALL COORDINATE & COOPERATE W/ UTILITY OWNERS IN THEIR REMOVAL, ADJUSTMENT AND/OR RELOCATION OPERATIONS SO THAT THE UTILITY WORK CAN BE ACCOMPLISHED WITHOUT IMPACTING THE CONSTRUCTION.

U.5 SEWER SERVICES LINES ARE OWNED AND MAINTAINED BY THE PROPERTY OWNERS OF THE PROPERTIES THE LINE SERVES. ANY DAMAGE TO SEWER SERVICE LINES SHALL BE REPAIRED TO A CONDITION AT LEAST AS GOOD AS BEFORE THE DAMAGE TO THE PROPERTY OWNER'S SATISFACTION.
