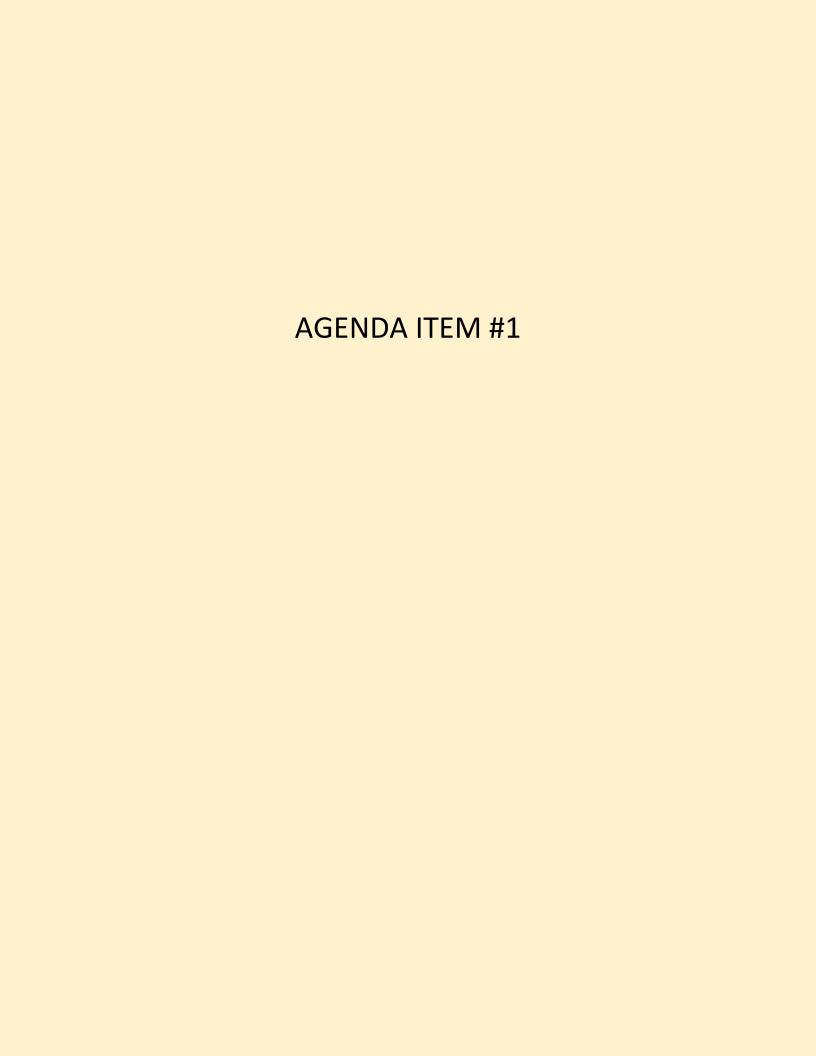

INTRODUCTION

This monthly report serves as an update to the Town Council and community members on key projects, activities, and community issues.

COMMUNITY CONVERSATION ON HOUSING – MARCH 27TH



TOWN OF RIDGWAY GRANULAR ACTIVATED CARBON (GAC) FILTER OPERATIONAL -**GAC-TREATED WATER NOW ENTERING DISTRIBUTION SYSTEM**

The Town of Ridgway is excited to announce that the Granular Activated Carbon (GAC) filter has officially been brought online at the Town's Water Treatment Plant. Starting at 2:30 p.m. today, any new water entering the distribution system will have been processed through the GAC filter.

The Town of Ridgway's Water Treatment Plant currently utilizes membrane filtration and, for many years, had been applying chlorine dioxide for taste and odor benefits. The chlorine dioxide

machine has been replaced with the GAC filter. A filter with GAC can remove certain chemicals and many organic contaminants from water, some of which produce odors or tastes to water. Granular activated carbon notably assists with the removal of per- and poly-fluoroalkyl substances (PFAS), which have become an increasing contaminant of concern for regulators. A GAC filtration system removes contaminants from the water supply by flowing water through the



GAC material, which pulls the contaminants like PFAS out of the water and forces them to stick to the filtration media.

This project has been in progress for several years, received grant funding from the Colorado Department of Local Affairs' Energy & Mineral Impact Assistance Program, and is an essential first step in addressing the Town's issues with emerging contaminants and unregulated chemicals in our drinking water. The Town is pleased to have taken the initiative to install this type of system.

BANNER STRUCTURE OVER SH62/SHERMAN ST.

Staff is in the process of working with Buckhorn Engineering to structurally engineer and design a banner structure over SH62/Sherman St. at its intersection with Cora St. We've pinpointed the location where the banner structure would be constructed, and it's roughly depicted in red in the image at right. The support poles and all other required elements of the banner structure need to fall outside of CDOT right-of-way and on Townowned property, and they need to be fully engineered to meet the American Association of



State Highway and Transportation Officials wind load requirements. In the month ahead, Buckhorn Engineering will conduct a geotechnical investigation at the site and pothole for utilities. Once the Town receives a design, it will be put out to bid so we can secure a contractor to construct the banner structure. Our aim is to have the banner structure in place by June 15.

GRAVEL REMOVAL AND BANK STABILIZATION WORK COMPLETED IN UNCOMPAHGRE RIVER AT ROLLANS PARK

Work has been completed on a gravel removal, channeling, and bank stabilization project in the section of the Uncompandere River along Rollans Park in Ridgway. The purpose of the work was to ensure the proper flow of the Uncompandere River by removing gravel buildup and adjusting flow lanes. Another aim of the project was to rebuild the west bank along the pedestrian path.

Work included excavating and moving river gravel from the pedestrian bridge area, starting from the concrete rock structure within the Uncompander River and proceeding north. Work also



included the rebuilding of the west bank using material from the east bank gravel bar, and removal of excess gravel material.

The work was necessary to meet the maintenance requirements of the Town's existing permit with the U.S. Army Corps of Engineers and to protect the Rollans Park area and surrounding properties from damage caused by continued streambank erosion.

Work was completed by a third-party contractor with the assistance of personnel from the Town's Public Works Department. The work took about 7 days to complete.

REQUEST FOR PROPOSALS – HOUSING NEEDS ASSESSMENT 2025

On Friday, March 14th, the Town plans to issue a Request for Proposals seeking proposals from qualified, professional consultants to conduct a Housing Needs Assessment (HNA) for the Town of Ridgway and Ouray County. The selected consultant will perform HNA services to assist the Town and County in achieving compliance with SB 24-174, through developing a strategy to assess current and future housing needs in the Town and County, analyzing data provided by staff, conducting market research and collecting additional data, developing methodologies to analyze data, conducting stakeholder engagement and coordinating with advisory groups, planning and coordinating with staff, and other methods. The selected consultant will consult the *Housing Needs Assessment Guide for Colorado Communities* that was issued in December 2024 to provide guidance on how to conduct a HNA, with a focus on state HNA requirements established by Senate Bill 24-174. The result should be a robust regional Housing Needs Assessment that addresses the unique needs of the two jurisdictions.

REQUEST FOR PROPOSALS – PROFESSIONAL ARCHITECTURAL AND ENGINEERING DESIGN SERVICES FOR THE RIDGWAY ATHLETIC PARK BASEBALL FIELDS AND PICKLEBALL COURTS

On Thursday, March 13th, the Town plans to issue a Request for Proposals seeking proposals from qualified, professional consultants for architectural and engineering design services for the Ridgway Athletic Park Baseball Fields and Pickleball Courts.

The successful proposer will specialize in sports facility design and engineering and should be adept at engaging community members in the design process. The Town seeks proposals for design of new baseball fields and pickleball courts in general conformance with what is depicted in the Ridgway Athletic Park Master Plan.

REQUEST FOR PROPOSALS – HOUSING ADMINISTRATOR

Ouray County, the City of Ouray and the Town of Ridgway are seeking proposals for a Housing Administrator. ANNUAL CLEANUP DAY EVENT

The Town will hold the annual Cleanup Day event on Saturday, April 26th in the lot behind the Ridgway Public Library on Railroad Street. The Town will provide dumpsters and residents are encouraged to bring their refuse to the site between 8:00 a.m. and 1:00 p.m. Alpine Bank is expected to hold their electronic waste recycling event in conjunction with the Town's event, at the same location. Also, Ouray County Public Health Agency is aiming to have a booth on site during the event to raise awareness about the proper disposal of e-cigarettes and vapes, which should not be disposed of in regular trash due to their potential environmental impact and safety concerns. Ouray County Public Health representatives will have a disposal bin on site, distribute educational materials on safe vape disposal, and provide information on the new disposal bins they plan to set up across the region.

ADOPT-A-HIGHWAY

The Ridgway Town Council has committed to picking up trash and litter along Hwy 62 from milepost 20 to 22 a minimum of two times each year. The agreement with CDOT expires in January of 2026. The time has come to pinpoint a date and time to hold another clean up event this spring or summer!

This route also has one quick stop in Ridgway and picks up riders at 6:40 a.m. The cost from Ridgway to Telluride is only \$4.

From Telluride to Montrose (Mon-Fri)

At the end of the day, the bus leaves Telluride at 5 p.m. and arrives in Montrose around 7 p.m. It will drop riders off in Ridgway at 5:50 p.m. The cost for the trip to Ridgway is \$4 and the trip from Telluride to Montrose is \$5.

The project's construction was spearheaded by OnSight Construction, owned and operated by Clint Estes, a local builder with established relationships with subcontractors and suppliers, enabling the attainment of significant discounts and in-kind donations of materials and labor.



Clint's standard project management fee is 10% of the projected budget. He committed to this project for 6%, a significant reduction that reflects his genuine dedication and commitment to the project and our community. That, and he simply is a nice compassionate fella.

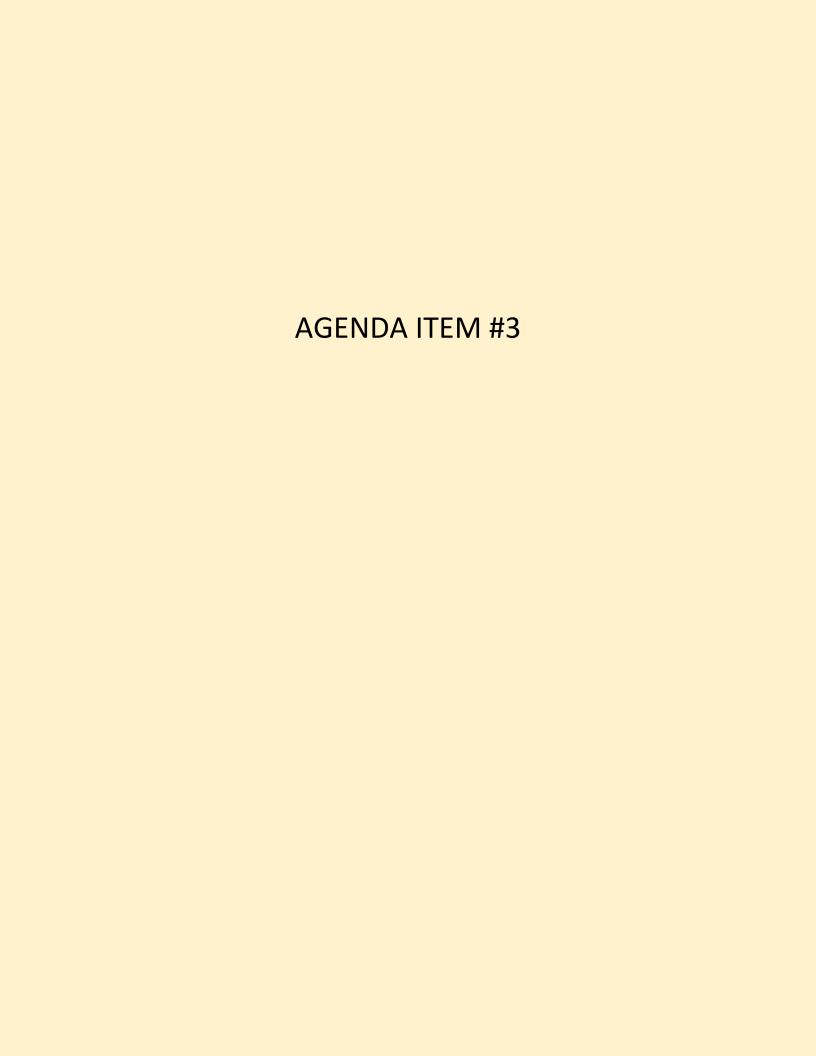
