

## ORDINANCE NO. 1-2010

AN ORDINANCE OF THE TOWN OF RIDGWAY, COLORADO, AMENDING TRAFFIC REGULATIONS IN THE TOWN CODE AND ADOPTING BY REFERENCE THE 2003 EDITION OF THE "MODEL TRAFFIC CODE FOR COLORADO"; PROMULGATED AND PUBLISHED AS SUCH BY THE COLORADO DEPARTMENT OF TRANSPORTATION, SAFETY AND TRAFFIC ENGINEERING BRANCH, 4201 EAST ARKANSAS AVENUE, EP 700 DENVER, COLORADO 80222; SUPERSEDING THE 1995 MODEL TRAFFIC CODE FOR COLORADO MUNICIPALITIES AND OTHER PROVISIONS INCONSISTENT WITH THE ADOPTION OF THE 2003 CODE; AND PROVIDING PENALTIES FOR VIOLATIONS

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF RIDGWAY, COLORADO, as follows:

### **SECTION 1:**

Section 15-1-1 and 2 of the Ridgway Town Code are is amended to read as follows:

#### **15-1-1. Adoption.**

There is hereby adopted by reference Articles I and II inclusive of the 2003 edition of the "Model Traffic Code for Colorado " promulgated and published as such by the Colorado Department of Transportation, Safety and Traffic Engineering Branch, 4201 East Arkansas Avenue, EP 700, Denver, Colorado 80222. The subject matter of said Code relates primarily to comprehensive traffic control regulations for the Town. The purpose of this Chapter and the Code adopted herein is to provide a system of traffic regulations consistent with State law and generally conforming to similar regulations throughout the State and Nation.

#### **15-1-2. Modifications and Deletions.**

- (A) The following provisions of the Model Traffic Code adopted herein are modified as follows:
- (1) Delete the words "by ordinance" in the first line of Subsection 1205(3).

(B) The following provisions of the Model Traffic Code are hereby deleted:

Subsection 1101(8), and Sections 1701, 1702, 1705, 1706, 1707, 1708, 1709, 1710, 1713, 1714 and 1715
